No NSG 142/2011/35 :- In pursuance of the verbal order of Principal Secretary to the Govt. of Assam, Food, Civil Supplies & Consumer Affairs Department during Video Conference held on 22nd May'2012, all Inspector/Sub-Inspector, FCS & CA, Nagaon are hereby directed to verify and check the population/FI Card register of the Fair Price Shop/GPSS agents of their respective area of jurisdiction with the Electoral Roll'2011 to weed out bogus/ineligible Family Identity Card.

The officers will prepare marked copy of the Electoral Roll at the time of verification and also mark the eligible/genuine names in the FP Shops/Agents population/FI Card register. After verification the area Inspector/Sub-Inspector will submit a comprehensive report to the undersigned within 7th June'2012.

The whole process is the part of computerization of PDS/TPDS which is being implemented under the directives of the Hon'ble Supreme Court of India.

Therefore any laxity on the part of the field officers will be viewed seriously.

The applications in proper format should be submitted to the FCS & CA, Branch of Deputy Commissioner's/Office,for Nagaon sadar sub-division within 15th Dec/2011 for verification at field level and issuance of APL FIC.
