The meeting was presided over by Deputy Commissioner, Nagaon and President of the District level Vigilance and Monitoring Committee, Nagaon. He welcome the members present and directed the Deputy Director, i/c FCS & CA and member Secretary of the Committee to read out the Minutes of the last meeting and action taken on the minutes of that meeting. The Deputy Director, i/c FCS & CA, Member Secretary of the meeting read out the minutes of the earlier District level Vigilance and Monitoring Committee meeting. Before going through the minutes of the last District level Vigilance and Monitoring Committee meeting, the Deputy Director, i/c, FCS & CA briefly narrated under power point the present status of implementation of National Food Security Act'2013, Randhanjyoti scheme etc. and Allotment, Lifting, Distribution position of all PDS/TPDS commodities in the district. He read out the important resolutions adopted in the G.P.S.S/Constituency level Vigilance and Monitoring Committee meeting so far held in the district.

The Deputy Director, i/c, FCS & CA read out the minutes of the last District level Vigilance and Monitoring Committee meeting held on 13/10/2012 and apprised the house on the status of action taken on the resolution adopted in that meeting. The Deputy Commissioner and Chairman of the district level Vigilance and Monitoring Committee interrupted and ask the Area Manager, F.C.I, Nagaon present in the meeting, the reason of F.C.I's failure to commence Paddy procurement in the last khariff year in the district and also the reason of F.C.I's failure to collect levy rice from the Rice Millers of the district. The Area Manager explain the Technical requirement etc. for Paddy and Rice procurement which the house found not satisfactory.

The Hon'ble Member of Parliament present in the meeting on request from the Chairman invited all concerned to ensure proper distribution of all PDS/TPDS items by the stake holders. Hon'ble MLA, Nagaon Sadar LAC participating in the discussion stated that though the situation in Public distribution has considerably improved, the FCS&CA Deptt. should take steps to ensure receipt of allotted PDS goods by the Consumers properly. The Hon'ble MLA, Raha and Rupahi also participated in the discussion and raised similar complaint. The house suggested to obtain arrival report of Atta and S.K. Oil from the GPSS and F.P. Shops and to involve G.P. President / G.P. Secretary in the Distribution process. The Chairman of the Committee suggested to obtain distribution certificate of atta and S.K. Oil from at least 10 PDS consumers of the FP Shops on rotation basis.

The Hon'ble Members from Nagaon Zilla Parishad urged upon in the meeting to effect allocation of PDS commodities to existing Women Co-operative Societies of the District. The house discussed in detail the resolutions adopted in the GPSS/Constituency level Vigilance and Monitoring Committee's meeting in the district during last one year.

After threadbare discussion, the following resolutions unanimously adopted in the meeting.

1. All GPSS of the District henceforth submit arrival report of wheat product to the district and sub-divisional Authority immediately after lifting from flour Mill concerned for causing physical verification by FCS&CA field officers.

2. All GPSS agents/ F.P. Shops of the district will submit distribution list of S.K. Oil signed by 10 nos of PDS consumers in rotation every month to the FCS&CS Field officers who in turn will issue the next quota of allotted S.K. oil to the F.P. shop agents concerned failing which the allotted S.K. Oil will not be issued to the F.P. shops dealer concerned and necessary proceeding for cancellation of the license of the F.P. shop agents will be drawn under provision of Law.
3. The State Government be requested to release the pending transportation reimbursement bill of the AAY rice, MMASY rice and under Mid Day meal scheme to the GPSS / WCCS of the District at an early date.
4. The state government be requested to take step to arrange allocation of PDS sugar to the nominees of the district in the interest of the PDS consumers.
5. The FCS&CA Field Officers will immediately hold the meeting of the FP shops level Vigilance and Monitoring Committees, constituted Panchayat wise meeting in three months interval with wide publicity amongst the PDS consumers of the area. The members of F.P. shops level Vigilance and Monitoring Committee will visit F.P. shops of their respective areas at regular interval and ensure proper distribution of PDS / TPDS commodities. The FCS&CA Field Officers will also arrange awareness campaign amongst the TPDS consumers regarding allocation of AAY/ BPL rice.
6. In view of the complaint on selection of in-eligible beneficiaries under NFSA-2013, all the Block Development Officers of the district will arrange scrutiny of the selected beneficiaries list of their respective development block and take necessary action for rectification involving the office bearer of Panchayats and FCS&CA Field officers.

The meeting ended with a vote of thanks from the Chair.



### Function and Responsibilities of the Committee :-

- (1) The Deputy Director, FCS & CA, Nagaon will be the convenor of the Committee and shall remain responsible for convening the Committee's meetings.
- (2) The Committee shall sit once in three month i.e. from 21<sup>st</sup> to 30<sup>th</sup> April, July, October & January.

- (3) The meetings should be held in the office of the Deputy Commissioner concerned.
- (4) The Committee will review over the functioning of the TPDS/PDS Scheme, MMASY rate and reports/suggestions of Sub-Divisional level and Constituency level V & MC discuss problems/difficulties/complaints/grievances etc. raised at the level of FP Shops/GPSS/Town Wholesale Consumer Co-Operative Society/SK Oil Retailer/Sub-Wholesaler/Gas Agencies and ensure disposal of these at the Committee level to the maximum possible extent and refer the undecided issues to the Director, FCS & CA and to the Govt. of Assam, FCS & CA Deptt. for appropriate action.
- (5) The Committee will examine and ensure the timely lifting & distribution of all PDS/TPDS items in the District as per norms on the basis of Sub-Allocations received from Director FCS & CA Assam.
- (6) The Committee will review the stock and delivery of PDS/TPDS items by FCI and also examine and review the functions of SK Oil Depot/Sub Whole depot/retailers of the District.
- (7) The Committee will suggest measures to streamline the PDS for making it more transparent and beneficial to the people, and propose appropriate action.
